## **Letter of Information**

The data may also be published in professional journals or presented at conferences, but any such presentations will be of general findings and will never breach individual confidentiality. Should you be interested, you are entitled to a copy of the findings.

**Will I be compensated for my participation?** Study participants will not be receiving compensation.
