Urban tree conservation

Did you know?

- Trees in Ottawa's urban core store or sequester enough carbon dioxide to offset 10 million car commutes to and from work.
- One large tree provides a day's worth of oxygen for up to four people.
- Wind protection and shade cover from trees can save households 10 to 50 percent in heating and cooling costs.
- Research shows that trees can increase property values nine to 30 percent.
- Trees help improve our water quality, as they filter surface water and prevent erosion.

The City's policy is to maintain 30 percent tree cover across the city. Currently, in urban areas of the city, there is only 17 percent tree cover. As Ottawa grows, we will undoubtedly lose trees to new suburban developments and infill projects. Ottawa is now one of the few major centres in Ontario that does not have any regulations in place for tree cutting on private land. The City is seeking your input on this issue.

Amy's Corner

Property Assessments and City Budget: As expected, we got our assessment notices the last week of October. The average increase for Kitchissippi Ward residences is 22.40 percent—well above the City average of 13.94 percent. In fact, our ward had the highest average outside the downtown ward of Somerset. This makes the City budget especially important, since this above-average assessment means a phased-in increase of 5.6 percent for 2009 and probably a similar increase in taxes for that year, even if there is zero increase in the tax rate. Your own assessment increase may be below the ward average so your increase may be less than that. In fact, if your percentage increase in value is less than 20 percent, the provincial portion of your taxes may decrease. The phasing-in means that a quarter of your total increased value will be added each year until 2012 when the full and new assessed value will be used.

Given the above and the likelihood of increased taxes in our area stemming strictly from increases in assessed value, the City Budget—slated for release on Nov. 4—seems likely to be of interest to many people. Information sessions on the budget will be held as follows:

2) Thursday, Nov. 27 from 7:30 p.m. to 9:30 p.m. at Churchill Seniors Centre, 345 Richmond Road: Councillor Christine Leadman.

If neither of these suit you, the nearest alternative is: 3) Tuesday, Nov. 18 from 7 p.m. to 9 p.m. at Ben Franklin Place, 101 Centrepointe Drive: Councillors Rick Chiarelli, Steve Desroches, Jan Harder, and Gord Hunter.

Official Plan Revisions: The City will hold special meetings to discuss revisions to the 2003 Official Plan and Infrastructure Master Plan on Nov. 24 (Planning and Environment Committee) and also on Nov. 27 (Agricultural and Rural Affairs Committee). The latter will focus on changes to policies that affect rural areas. A draft amendment was sent out earlier this year and the agenda of these meetings will include the revised version. The draft amendment will be tabled in January with adoption scheduled for March. Possible changes to the urban boundary and intensification policies will probably be the focus of discussion. Development projects in our ward: The development along Scott at Winona seems to be proceeding as the construction equipment was there the other day. A City-related project is the addition of a new larger water pipe from the filtration plant; this will result in the closing of Bayview Road at Scott Street for several weeks. Work is also underway at the former Canadian Tire gas station on Richmond Road, probably at this stage mainly cleaning up the site.

Trees: The City held several workshops and discussions the last week of October and first week of November, leading up to possible policies re: conservation of trees, particularly distinctive trees.

Trees are an important element in making our community a pleasant place to live. City trees—those in the city road allowance (such as the area that might be used for sidewalks) and in parks—are protected. Those on private property are not. Quite a few Ontario municipalities have tree-cutting by-laws. Discussions here have included ways to

by-laws. Discussions here have included ways to protect distinctive trees, as well as a by-law to require a tree preservation and protection plan before tree cutting or development can occur on vacant land. As well as its current tree-planting work, the City might also engage in stewardship promotion on behalf of trees. If you have opinions on the ways that the City should protect and enhance our tree cover, you might let our Councillor know since the results of these discussions will probably be discussed at Council.
